**INTERNATIONAL COOPERATION OF THE  
NATIONAL POLICE OF UKRAINE**

International cooperation is a key element of the mechanism of implementation of state policy in the field of fighting crime and ensuring law and order in the state. Separate spheres of international cooperation of bodies and units of the National Militia of Ukraine are the basis for their successful performance of their special tasks and functions, which, as a rule, contribute to ensuring not only the national security of Ukraine, but also international security.

The *purpose* of the article is to study the legal aspect of international cooperation of bodies and units of the National Police of Ukraine. The stage of formation of administrative and legal regulation of international cooperation of bodies and units of the National Police established the following *tasks*: 1) creation of international cooperation in various spheres of police activity: from fighting crime to raising the professional level of police officers abroad; 2) development of international relations with police departments of leading foreign countries and countries of the European Union; 3) intensification of cooperation between the police of Ukraine and the European Union regarding joint activities at the international level; 4) creation of favorable conditions for effective international interaction (cooperation) by concluding international treaties and agreements; 5) integration of the National Police of Ukraine into the European police system and increasing the powers of the Ukrainian police in the international community, etc. A characteristic feature of the common space of justice, freedom and security, as noted by O.I. Bezpalov, there is a need to ensure a harmonious combination of its two aspects: external and internal. It is clear that the internal aspect of this space involves joining the efforts of law enforcement agencies of the member states of the European Union to ensure internal security and maintain law and order in the territory of the entire community. It should be emphasized that the International Technical Cooperation Service of the National Police closely cooperates with the Department of International Cooperation of the Ministry of the Interior of France, which serves as a guarantee of an effective administrative and legal mechanism for the implementation of international cooperation of the French police.

The interaction between the mentioned divisions takes place on the following basis: - ensuring the participation of each police officer in international cooperation in the relevant field of his activity;

- control of the Department of International Cooperation of the Ministry of Internal Affairs of France for compliance with legislation in the field of

international police cooperation, assessment and analysis of compliance with modern problems;

- establishment of effective interaction of the National Police of France with foreign police bodies and international law enforcement bodies;

Experience in administrative and legal regulation of international cooperation of such an international law enforcement agency as the International Association of Gendarmerie and Police Forces with Military Status (International Association of Governments and Police Forces with Military Status). FIEP was launched in order to develop law enforcement and military cooperation and exchange experience between the relevant structures. FIEP is an association of national gendarmerie and police with military status. The objective of FIEP (which started with the Armed Forces of France, Italy, Spain and Portugal) is to expand and strengthen mutual relations, to promote innovative and active analysis of forms of police cooperation and to evaluate its model of organization and structures abroad. It should also be noted that the activity of Nordic-Baltic (NBNP) is an organization of police officers, founded in April 2001. Its members are all the countries of Northern Europe - Sweden, Finland, Iceland and Denmark, as well as the Baltic countries - Lithuania, Latvia, Estonia, which actively participate in organized events.

The main objective of the NBNP is to promote equal opportunities for women and men in the police, to increase the number of women in leadership positions in the police, and to establish good professional relations and exchanges between police organizations in member states.

Taking into account the above, it is necessary to take into account during the improvement of the mechanism of administrative and legal regulation of international cooperation in the activities of the National Police of Ukraine with the aim of higher quality and effective provision of their activities the following: - Implementation of special international programs for training, retraining, advanced training (internship) police personnel on issues of establishing the Institute of International Cooperation in various spheres of their activity; - establishing a close partnership of international relations in the field of expert and judicial support between research experts and judicial centers of the Ministry of Internal Affairs of Ukraine; - strengthening the role of the international cooperation department of the National Police of Ukraine as a coordination center for the interaction of bodies and units of the National Police of Ukraine with other international law enforcement bodies, bodies and services and police services;

**PROVISION BY THE NATIONAL POLICE OF UKRAINE  
OF PUBLIC SAFETY AND ORDER UNDER MARTIAL LAW**

Now difficult time has come in Ukraine, because of the war, martial law has been imposed in our country. Martial law is a special legal regime introduced in Ukraine or in some of its localities in case of armed aggression or threat of attack, danger to the state independence of Ukraine and its territorial integrity. Despite this, the National Police of Ukraine fulfills its duties in the field of public safety and order.

Protecting public order under martial law, the police use such methods of social regulation as persuasion and coercion, in particular, administrative suspension. Explanatory work as the main method of law enforcement activity, convincing citizens of the need for conscious and voluntary compliance with legal requirements, stopping anti-social behavior, preventive work in labor groups and with individuals is a necessary condition for promoting effective mobilization.

Also, the police use special measures, which, although they are used much less often and only in exceptional cases, but if otherwise it is impossible to stop illegal behavior, then they use measures of physical influence, special means and the use of weapons. These measures are applied only after a warning about their use, subject to strict compliance with the requirements of the law.

During the martial law in Ukraine, a curfew is imposed from evening to morning in all cities. A national curfew was first imposed in Ukraine in March,
