

SPECIAL FEATURES THE POLICE UNITS IN GEORGIA

The Ministry of Internal Affairs of Georgia is a law enforcement agency of the country. The main goal of the Ministry is to reduce the number of offenses, to ensure citizens living in a peaceful and secure environment, to protect their rights in compliance with the standards of democratic and legal state. In order to achieve this goal, the Ministry's tasks include crime prevention, effective response, quality service and establishment of close and trusted relationships with the public. The Ministry carries out its activities in accordance with the law, democratic standards and ethical norms.

MIA activities are based on the principles of lawfulness, humanity, justice, publicity, transparency, respect for the honor and dignity of the person. In addition, the Ministry recognizes that the trust and respect of the public is only possible through ethical and humane treatment. Today, the Ministry's activities are carried out with new visions and approaches.

MIA has been formed as an independent, impartial and publicly oriented law enforcement organization. The Strategy Development Strategy for the Ministry of Internal Affairs was elaborated for the purpose of institutionalizing and reforming police development, strategic planning processes. The existing practice has been replaced by the constant evaluation, analysis, needs, and the use of resources to rational use. The Ministry closely cooperates with the public and takes active steps for its informing and ongoing processes. The activities of the Ministry are based on publicity and transparency. Citizens can get acquainted with the public information at the Ministry of Internal Affairs. The MIA is focused on society and its needs, its activities are considered as a public service, based on accountability and respect for human rights.

The Security Police has over 10 000 objects in the whole territory of Georgia (both technical means and police force). Important strategic objects include: international airports, national treasure, diplomatic missions accredited in the country, railways. Security Police - Ministry of Internal Affairs is a legal entity of public law. Its main activity - protection of property and personal security of legal / physical persons. Mission A - public security and a healthy environment.

Security Police is a security service equipped with modern equipment and constantly updated technologies. The risks associated with protection are insured by the international insurance company. The Security Police Department ensures the prevention of crime and other offenses on the objects of protection with modern and continuously updated technologies. To this end, the employee of the Security Police Department is entitled to carry and use firearms and other special means as provided by the applicable legislation.

Police Department

The territorial body of the Ministry of Internal Affairs of Georgia is a territorial unit of the Ministry which is accountable and responsible to the Minister of Internal Affairs of Georgia.

The legal basis for the activity of the territorial entity is the Constitution of Georgia, international treaties and agreements of Georgia, laws of Georgia and subordinate acts, issued by the Ministry of Internal Affairs under the legislation of Georgia.

The activity of the territorial body is based on the principles of lawfulness, respect for the honor and dignity of the person, social justice, humanism and publicity.

The tasks of the territorial body are within the competence:

- protection of the rights of state interests, human rights and freedoms and legal entities from unlawful infringement;
- Detecting, preventing, preventing offenses and other offenses;
- Protection of public order and public security;
- Preliminary investigation and criminal prosecution;
- search and detention of suspects, defendants, defendants, criminals, as well as other offenders to carry out relevant measures to find missing persons;
- Fight against crime and crimes according to settlements, collect data on criminals and offenders and provide information to the heads of the relevant units;
- Exercise other tasks provided by the legislation.
