

## **THE MEANING OF THE TERM DUTY LAWYER**

A lawyer is someone who is licensed to practice law, and whose obligation it is to uphold the law while also protecting their client's rights. Some duties commonly associated with a lawyer include: providing legal advice and counsel, researching and gathering information or evidence, drawing up legal documents related to divorces, wills, contracts and real estate transactions, and prosecuting or defending in court.

A lawyer, also known as an “attorney,” “counselor,” solicitor,” “barrister” or “advocate,” is an individual licensed by the state to engage in the practice of law and advise clients on legal matters. Lawyers act as both advocates and advisors on behalf of their clients.

Lawyers generally perform actions on behalf of clients in court, advising them as to the proper course of action in civil and criminal activities. Attorneys tend to specialize in one aspect of the law, such as product liability, criminal justice, family law, or elder law. They may also advise companies on the validity of contracts and mergers or other aspects of corporate governance. Unlike many criminal justice careers, lawyers spend the majority of their time in offices or in the courtroom. Aspiring attorneys must have strong critical thinking and public speaking skills as well as research abilities.

A duty lawyer is a lawyer who offers services on a volunteer basis. Often, they represent clients who meet income eligibility requirements. There may be a small fee for the duty lawyer service, which may be lowered if the defendant is unemployed or waived in cases of financial hardship.

The duty lawyer is able to give general advice to defendants about the type of plea to enter, any defense they might have, and potential penalties, among other matters. They may or may not be allowed to represent the defendant at their hearing in court. Typically, they serve to provide free advice and/or representation in urgent matters to people who have not been able to arrange legal representation. Specific authority and policies vary by jurisdiction.

Duty lawyers help people who are attending a court or tribunal hearing and have not had the chance to see a lawyer beforehand. This service is free and can cover: child protection, youth crime, adult summary crime, intervention orders, family matters, some civil matters, such as Mental Health Tribunal hearings.

Help provided by the duty lawyer depends on the person's circumstances, and may include information, legal advice or representation in court. For duty lawyer services for adult criminal offences, an income test applies to all accused not in custody.

A civil lawyer focuses on cases involving wills, trusts, divorce, child custody, litigation, contracts, mortgages, titles, leases and damage suits. Payments and records management for private practitioner duty lawyers. Accredited private lawyers are paid for duty lawyer services delivered in accordance with a rostered commitment to do so, at the applicable rate set out in the Fees section, upon submission of a claim. Duty lawyers in the Family Division of the Children's Court. Children who are over 10 years of age and assessed by the lawyer as mature enough to give instructions to their lawyer are directly represented by the lawyer.

Criminal lawyers who participate in Magistrate Courts are also known as criminal defense lawyers and public defenders, defend individuals, organizations and entities that have been charged with a crime. Criminal lawyers handle a diverse spectrum of criminal cases, ranging from domestic violence crimes, sex crimes, violent crimes and drug crimes to driving under the influence (DUI), theft, embezzlement and fraud. This interview with a criminal defense attorney provides insight into one criminal lawyer's career path and daily practice.

A career as a lawyer is an extraordinary calling. However, becoming a lawyer is an enormous undertaking in terms of time commitment and financial investment.
