This psychoprophylaxis in the internal affairs implemented in two main directions. The first area – a psihoprophylic implementation of measures aimed at controlling and maintaining health personnel as a condition of performance. The second trend – psihoprophylic police work with the public, aimed at preventing and minimizing criminal factors in society caused by the tendency to reorient the law enforcement agencies to implement punitive functions for implementation of socially oriented tasks.

Psihoprophylic work and psychological support operational performance provides organizational, regulatory, psychological, educational, psychological and health care measures for the conservation, restoration and strengthening of social and preventive welfare and health of
