**ORGANIZATIONAL AND ADMINISTRATIVE FRAMEWORK
OF INTERACTION WITH EMPLOYEES KMSD PSYCHIATRIC
SERVICES EDUCATION SYSTEM**

Forms of interaction are considered criminal police for kids interior Ukraine with psychiatric services Ukraine's education system and its organizational and managerial foundations.

Key words: *interaction; forms of interaction; the criminal police for children; psychiatric services of education; prevention activities*

Reforming the institutional and legal framework of law enforcement, improving management structures will require activation of their cooperation with government and non-government organizations and agencies, including the psychological service of education in crime prevention and the prevention of juvenile crime.

Various aspects of crime prevention among minors investigated R.I. Blahuta, A.I. Bondarchuk, O. Zmanovska, L.I. Frost, R.G. Smith, D.M. Ticino, V.M. Orzhehovska, V.F. Morhun, A. Nechaev, K. Gray, M. Fitsula more. But the coordination and cooperation of all actors prevention of juvenile delinquency were considered insufficient, and the goal of our paper is to identify the forms of interaction KMSD Interior Ministry of Ukraine for Education Psychological Service of Ukraine and its organizational and managerial foundations.

Maintenance work the internal affairs carried out in close collaboration with other subjects related to adolescents: schools, business administration, military, media and more. Close cooperation is carried out by the court, prosecutor, educational and employment agencies.

Interaction criminal police for children with psychiatric services of the education system - is organized in accordance with the applicable legislation, departmental and interdepartmental regulations for Economic Cooperation process (concerted or joint

action) aimed at achieving effective results prevention of juvenile delinquency and solve complex Problems faced by the designated entities. Interaction and coordination of law enforcement and psychological services Ukraine's education system is based on the following principles: the rule of law, equality of all members of coordinating activities, independent of each organ within certain statutory powers; publicity to the extent that it does not conflict with the legislation on protection human rights and freedoms, the state or other secrets protected by law, responsible leaders for joint decisions [3].

Interaction criminal police for psychiatric services for children with the education system of Ukraine may take the form of:

- Joint coordination meetings of heads of psychological services and law enforcement agencies;
- Exchange of information on combating juvenile delinquency;
- A joint visit to the region to carry out joint actions , audits and assist local law enforcement agencies and psychiatric services of the education system;
- Study and dissemination of good practices;
- Carrying out joint activities for target detection and prevention of crimes and identify the causes and conditions that contribute to their occurrence;
- The mutual use of the law enforcement agencies for training of social educators and psychologists, joint seminars and conferences;
- Publication of general orders, instructions, training and other newsletters, organizational and administrative documents;
- Issue of joint papers (collections) and information publications;
- Development and adoption of agreed plans diyalnosti coordination.

Interaction criminal police for children with psychiatric services of the education system – is organized in accordance with the applicable legislation, departmental and interdepartmental regulations for Economic Cooperation process (concerted or joint action) aimed at achieving effective results prevention of juvenile delinquency and solve complex Problems faced by the designated entities. Interaction criminal police for psychiatric services for children with the education system of Ukraine may take the form of:

- A joint visit to the region to carry out joint actions, audits and assist local law enforcement agencies and psychiatric services of the education system;

- The mutual use of the law enforcement agencies for training of social educators and psychologists, joint seminars and conferences;
- Publication of general orders, instructions, training and other newsletters, organizational and administrative documents;
- Issue of joint papers (collections) and information publications;
- Development and adoption of agreed plans diyalnosti coordination.

The interaction of state bodies and Psychological Service of Ukraine in the field of education prevent juvenile crime occurs in the form:

- Each other informed about the status, dynamics and causes of juvenile delinquency, some facts teenagers committing crimes and offenses;
- Drawing up of joint work plans, planning coordinated actions aimed at the prevention and juvenile crime prevention;
- Carrying out coordinated activities or hanging out specific measures to combat juvenile delinquency;
- Joint seminars to exchange experience, interagency meetings, participation of some of the interacting bodies at meetings and conferences , which are held by other bodies;

- Use other forms of interaction (eg, assisting, facilitating the work).

Consider a given form of interaction in more detail.

1. The main form of interaction KMSD Internal Affairs of Ukraine with psychiatric services of the education system of Ukraine is the mutual exchange of information. One of the conditions for the successful implementation of prevention activities – ensuring timely and complete information exchange between actors prevention. Information and analysis and is the basis of the functioning of the administration of juvenile crime prevention. The majority of scholars emphasize the importance of timely collection of information on adolescent offenders, processing, storage and creation of appropriate conditions for use, police and employees of educational psychological services [1, p. 73].

An example of this collection of information is accounting. In this regard, it is worth noting that the main unit, which deals with the prevention of juvenile crimes in the system of police, criminal police is juvenile (KMCD). According to the instructions of the organization of the criminal police departments for children approved by the Ministry of Interior of Ukraine from 19.12.12 № 1176 paragraph 4.1 which states that employees are KMSD unit preventive registration of children and alphabetical reference accounting adults [4].

In addition, units KMSD is under § 4.23 How alphabetical reference records of adults who were on probation, and for which execution of a sentence of imprisonment suspended for the commission of criminal offenses involving the child in criminal activity, alcoholism, gambling, begging, child worship to the use of narcotic drugs, psychotropic substances or their analogues and others.

Observe that in practice with the provisions of the said Regulations are many disadvantages associated with concealing evidence of the commission of minors in schools and at the residence of petty theft, vandalism, use of narcotic drugs, psychotropic substances, alcoholic beverages. Such cases are caused by unwillingness to inform the internal affairs of an offense which takes place in schools, inadequate work of officials – the subjects of prevention and other factors. This indicates that the information and analytical activities of prevention, especially during the acquisition,

processing and analysis of evidence of juvenile delinquency, in need of improvement.

2. Another form of interaction between the criminal police in cases of psychological services for children and the education system of Ukraine is planning teamwork.

Appropriate planning should be done at all levels, from regional and municipal bodies that juvenile crime prevention activities to the central executive which joint action plan gives the appearance of government programs. An example is the state program to combat crime [7], the concept of public policy in the field of crime prevention until 2015 [8].

We believe that priority attention is required to develop and implement national programs antypropahandy smoking, alcohol consumption, drug use, which is not yet available in the country [5].

At the level of the district (city), it is advisable to develop joint work plans for the district and the city administration are located in the serving area of special educational facilities and educational institutions. Joint planning needs and develop targeted preventive raids and operations.

3. Another form of prevention is the interaction of inter-agency raids. The purpose of the raids - social and legal protection of children and the prevention of homelessness and neglect. These preventive measures can arrange homeless children to schools of social protection and influence the children who use alcohol, drugs or psychotropic substances. In this respect, we note that currently fully utilized appropriate safety facilities provided for by the Law of Ukraine «On Protection of Public Morality» on November 20, 2003. In establishing the causes and conditions that led to the increase in the number of children who did crimes while intoxicated, as well as teenagers who were arrested for drinking alcohol in public places and appearance in public in a drunken state is that the penalty is not an effective deterrent.

Due to significant demand and popularity among children of alcoholic beverages and tobacco businesses more profitable to pay a fine and continue trading activities. Also faulty collection and processing of documents confirming the fact of the sale of the child of alcoholic beverages or tobacco products can not bring to justice the perpetrators. Moreover unprofessional actions of the police officers give grounds for appeals to the courts and the Ministry of Interior.

4. Joint workshops to exchange experience, interdepartmental meetings, attended by representatives of some economic interaction in meetings held by others, allow employees cooperating agencies to establish business contacts and connections, be aware of the situation, to the serving area, learn about new techniques and methods of work, improve their skills. Thus, the meeting together with employees KMSD and psychological service of education personnel analyze the state of the education system work to prevent the systematic use of alcohol, drug addiction, substance abuse among minors in the servicing area in schools.

5. Other forms of interaction of juvenile crime prevention: preparing joint proposals, joint meetings with the population living in the serving area, performing in schools, presentations and publications, «the legal universal education» and others.

Proposals and presenting business interaction involves making common decisions and proposals. Yes, KMSD and psychiatric services of the education system, making the appropriate authorities and institutions jointly agreed proposals, submissions provided by law in respect of juveniles who have committed offenses or anti-social acts in respect of their parents or legal representatives or officials who do not or not properly perform their duties with education, training, juvenile or adversely affect their behavior or treat them cruelly.

Of great importance in the fight against juvenile delinquency are coordinated use by carrying out preventive activities of the media. It can be used in such forms as publications, conducting regular columns on the same topic, organizing debates on radio or television. This will facilitate the formation of positive public opinion about the activities of internal affairs in general and sub KMSD particular propaganda speeches in educational institutions (schools, colleges) on issues related offenses and juvenile offenses and their prevention. These activities will attract up on prevention of juvenile delinquency various social and religious organizations, movements and attention of many segments of the population.

Juvenile subjects interaction appropriate conduct «legal universal education» in educational institutions area, including at parents' meetings, and during his stay in juvenile summer camps.

One of the areas of interaction KMSD and psychological service of legal education is education of students. Certain topics in

the system of legal education classes students are explanations simple and yet important concepts such as crime, administrative offense, injury, age of criminal responsibility of minors and others. The course police have to explain basic legal questions about criminal and administrative liability of minors, as well as for the purchase of beverages (which will be the one who has acquired the one who sold it, it would be for beating, torture and removal for Camcorders Cell phone, etc.).

Planning for such a system of classes (their schedule) should be done at the beginning of the school year when there is planning of a psychologist for a year.

The interior creates institute school police officers, which is that in schools, introduced the principle of the territorial, that is, each of them assigned KMSD worker who meets with the administration of schools and representatives of parents' committees, lectures and workshops, aimed at developing children pravosvidomoyi behavior skills for a healthy lifestyle [3].

Interaction employee KMSD with officials psychological service of education (practical psychologists and social pedagogues) is about the materials, which operates practical psychologists and social pedagogues. This information in most cases is confidential, containing information about the training and education of the child, its dynamic growth, relationships with parents and friends, family environment and financial situation.

Employee psychological service of education (practical psychologists and social workers) are mandatory to keep the following documents:

- Work plan;
- Individual student card;
- Passport social class (class teacher fills). On the basis of social class social passports teacher fills passport social institution, logbook care for children in difficult circumstances.
- Registration card family (on which the social support). It indicates the type of family (large, incomplete, poor), number of family members, the basis for the organization of social support according to the Joint Order of MES of Ukraine on June 14, 2006 N 1983/388/452/221/556/596 / 106 «on approval of the interaction of social work with families who find themselves in difficult circumstances»;

- Journal of daily accounting work;
- Log of complaints of students, parents, teachers (which indicates the problem appeal, summary advice). This information is confidential and is available only with the permission of the director of the institution, the head of district (city) Center for Applied Psychology and Social Work and practitioner;
- Journal of corrective and recovery, and developing work a practical psychologist (social teacher) to certain categories of students;
- Individual counseling protocols practical psychology (social pedagogy) – contains addresses the problem and a summary of consultation. This information is confidential and is available only with the permission of the director of the district (city) Center for Applied Psychology and Social Work or practitioner ;
- Individual cards psychological-pedagogical diagnosis of students, which includes socio- demographic passport student and his family;
- Card health and child development, including the information on the adequacy of behavior, especially the contact , the presence of interest in interaction with adults, a measure of independence , the state of emotional and volitional [6].
- Through analysis of these documents KMSD worker can figure out the following questions:
 - 1) health status and history of the child;
 - 2) The conditions for the development and education of the family;
 - 3) the results of psychological diagnosis (personality traits , character, inclinations, habits, temperament);
 - 4) the content, frequency of individual remedial work psychologist (as was done many times, if the child is aggressive and parents seeking help to diagnose, how would such appeals).

However, there are a number of documents which, in our opinion, is particularly important for employees KMSD conducting individual prevention relative to the individual child. This individual card that is put in the case of regular absenteeism pupil who has behavior problems (deviant manifestations), has a significant lag in education. In addition, this card contains information about the social portrait of the family.

Recommended ways of working with students KMSD employees:

- Lecture;
- Counseling (group, individual);
- Demonstration movies;
- Play games.

The methods of work of employees KMSD with students include:

- The method of discussion;
- A method of problem situations;
- Lectures;
- Independent work;
- A survey.

We believe that a fruitful interaction between the criminal police in cases of children with psychological services staff education system provided for joint activities. For example, the psychologist will conduct a lecture and police questioning or demonstration movie on the same topic, Will the real examples from practice on a specific topic of the lecture. In such cases, the planning of joint activities must directly relate to the practical examples. In addition, an important role in the legal education of children playing legal universal education of parents. The main issues which may relate to such education may be to identify the signs of drug use (on the grounds of pale, sleepy, bad mouth), how to detect whether a child has been subjected to violence, or knows the child and his parents where in the «den» where trade «sticks».

In our view, an essential factor for normal joint activity is the organization of effective control. Control inherent in any management activities, this solution the binding performance of the tasks and objectives as psychologists and social pedagogues educational institutions, and by the criminal police in the affairs of children. Preventive activities in some cases associated with a particular risk because such measures must be carried out in the presence of a police officer. The essential problem is that the law enforcement bodies there is a significant shortage of personnel, which affects the efficiency of interaction.

Thus, analyzing the organizational and managerial principles and interoperability of KMSD psychological service of education in Ukraine is worth noting that the majority of preventive measures aimed at the

consequences of criminal behavior of juveniles, but not its cause. Therefore, it can be a promising direction for further research.
